Kindly note that there are two Affidavits as Annexure-I & II. The Annexure-I is to be signed by the student and Annexure-II shall be signed by the parent / guardian.

In case a student does not submit the same he/she shall not be allowed to the classes. It is further, requested that this information be passed amongst friends.
