Policy : SC/ST Policy

1. **General :**

India is a country of diversity. It is a hub of different religions, castes and cultures. However, the Indian society is characterized by an entrenched system of social stratification. Social inequalities have led to denial of access to materials, cultural and educational resources to the disadvantaged groups of societies. Higher education is a tool for social and economic equality; therefore, the SRMGPC has constituted SC/ST Committee as per AICTE norms.

2. **Objectives :**

According to AICTE norms, the SC/ST committee (As per the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act 1989, No 33 of 1989, dated 11 November 1989) has the following objectives:

- a. To implement the reservation policy for SCs/STs in the Institution; collect data regarding the implementation of the policies in respect of admissions, appointments to teaching and non-teaching positions in the Institution, and analysis of the data towards fulfilling the required quota.
- b. Promotes the special interest of students in the reserved category and to provide special inputs in areas where the students experience difficulty.
- c. Conduct remedial coaching classes on life skills, personality development, writing assignments and making presentations and also have to organize interactive sessions and informal meetings with students to attend to their personal, social and academic problems.

3. **SC/ST Committee :**

The constitution of the committee is as follows –

- a. Associate Director (Ex-Officio) - Chairperson
- b. Professor / Associate Prof (any category) - Member Secretary
- c. Teaching Faculty (SC/ST Category) - Member
- d. Non-Teaching Staff (SC/ST Category) - Member
- e. Student (SC/ST Category) - Member

(One member must be Female)

4. **Frequency of Meeting:**

According to the regulations framed by AICTE, the Committee should meet at least two times in a year.





5. **TENURE and QUORUM:**

The tenure of members and the special invitee shall be of two years. The quorum for the meeting including the Chairperson shall be three. The details of the Committee will be uploaded on the College website.

The Committee Member(s) will meet the concerned students, understand their problem and take necessary action and/or render them necessary advice/help to resolve the matter as per guidelines issued by Govt. vide the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act 1989, No 33 of 1989.
